Dear Parent/Guardians:

Delran High School, in partnership with Rowan College at Burlington County (RCBC), offers students taking select courses an opportunity to earn both high school and college credit. Your child is taking one or more of the courses that qualify. Attached is a list of the dual credit courses that are approved by RCBC's College Accelerated Program (CAP).

These courses are taught during the regular school day by members of the Delran High School staff who have been certified as RCBC adjunct professors. Students who would like to receive college credits will be required to complete the RCBC registration process and pay the RCBC tuition. CAP fees for the 2017-2018 school year are as follows: \$150 for a class equal to three or four credits at RCBC, \$300 for a class equal to six or eight credits at RCBC. Checks or money orders are made payable to RCBC; cash will not be accepted. The application process involves completing a RCBC application and obtaining the signatures of Mrs. Galati and parent/guardian. **If your child is registering for more than one CAP course, all courses must be listed on one application form with one check/money order written for the total tuition.** The completed RCBC application, along with the tuition, must be returned to Mrs. Newman in Guidance no later than Friday, October 27, 2017. Please note that the student must earn a "C" (70-79) or better in order to be granted college credits.

**If your child is an AP student, he/she will still be eligible to take the AP test in the spring and is encouraged to do so. CAP is not intended to replace the AP program, but offers another option for students to earn college credits.**

Delran High School and RCBC strongly recommend that each student research the policies of any New Jersey state, private, or out of state college or university you are considering to determine their position regarding CAP credits. Once the payment and application have been sent to RCBC, there will be no refunds if a college/university does not accept CAP credits.

Students must request a transcript, through Rowan College at Burlington County, upon successful completion of the CAP class. They will be sent a week or so after the request is made and transcripts are free of charge. A request form is attached.

Once again, the **application deadline is Friday, October 27, 2017.** Late registrations will not be accepted and CAP registration is non-refundable. Please take the time to discuss this opportunity with your child.
