Dear Parent/Guardian & Student,

In order to attend the 2019 JUNIOR-SENIOR PROM, we are requiring parents/guardians and students to read, understand, and sign below.

DHS students attending this function with students from other school districts or people out of school are required to have their guest complete this form as well. The guest must provide a School I.D. card or other form of identification when asked. **The guest is also expected to follow and adhere to the guidelines as written and have a picture I.D. card.**

I understand that...

1. Each student and/or guest attending this DHS function will be subject to having a breathalyzer test.
2. Students suspected of being under the influence of alcohol or drugs while attending this function will be required to take a blood, urine and/or breathalyzer test.  
If the test is positive, the student will be disciplined in accordance with school policy and referred to the Delran Police Department. Furthermore, exclusion from future school activities, from placement on the Restricted List, as well as the loss of other privileges, will be initiated.
3. Any inappropriate or unacceptable behavior including but not limited to smoking, drinking, under the influence of alcohol and/or a controlled, dangerous substances, insubordination, inappropriate dress/clothing, unsafe or illegal acts will result in the guest being instructed to leave the event and being referred to the proper authorities. Definitions of such behaviors are at the discretion of the administration.
4. Students attending this school sponsored event must arrive by 7:30 pm and remain until at least 10:30 pm. Students arriving after the announced time will **not** be admitted. In addition, students will **not** be permitted to leave the building and return.
5. Anybody over the age of 20 years old may not attend as a guest. Participants must be minimally in 9<sup>th</sup> grade. All participants MUST have a Prom Promise.
